(1) Within 30 days from the date of entry of this order, the parties are directed to show cause why this appeal should not be dismissed or summarily affirmed. See 28 U.S.C. § 1915(e)(2)(B)(i) (in IFP proceedings, providing the court shall dismiss an appeal upon determination it is frivolous); *Mallard v. U.S. Dist. Ct. for S. Dist. of Iowa*, 490 U.S. 296, 307-08 (1989) (explaining that while § 1915 "authorizes courts to dismiss a 'frivolous or malicious' action, . . . there is little doubt they would have the power to do so even in the absence of this statutory provision"). A failure by Mr. McDermott to respond to this order will result in dismissal for failure to prosecute his appeal.

(2) All proceedings otherwise are stayed.

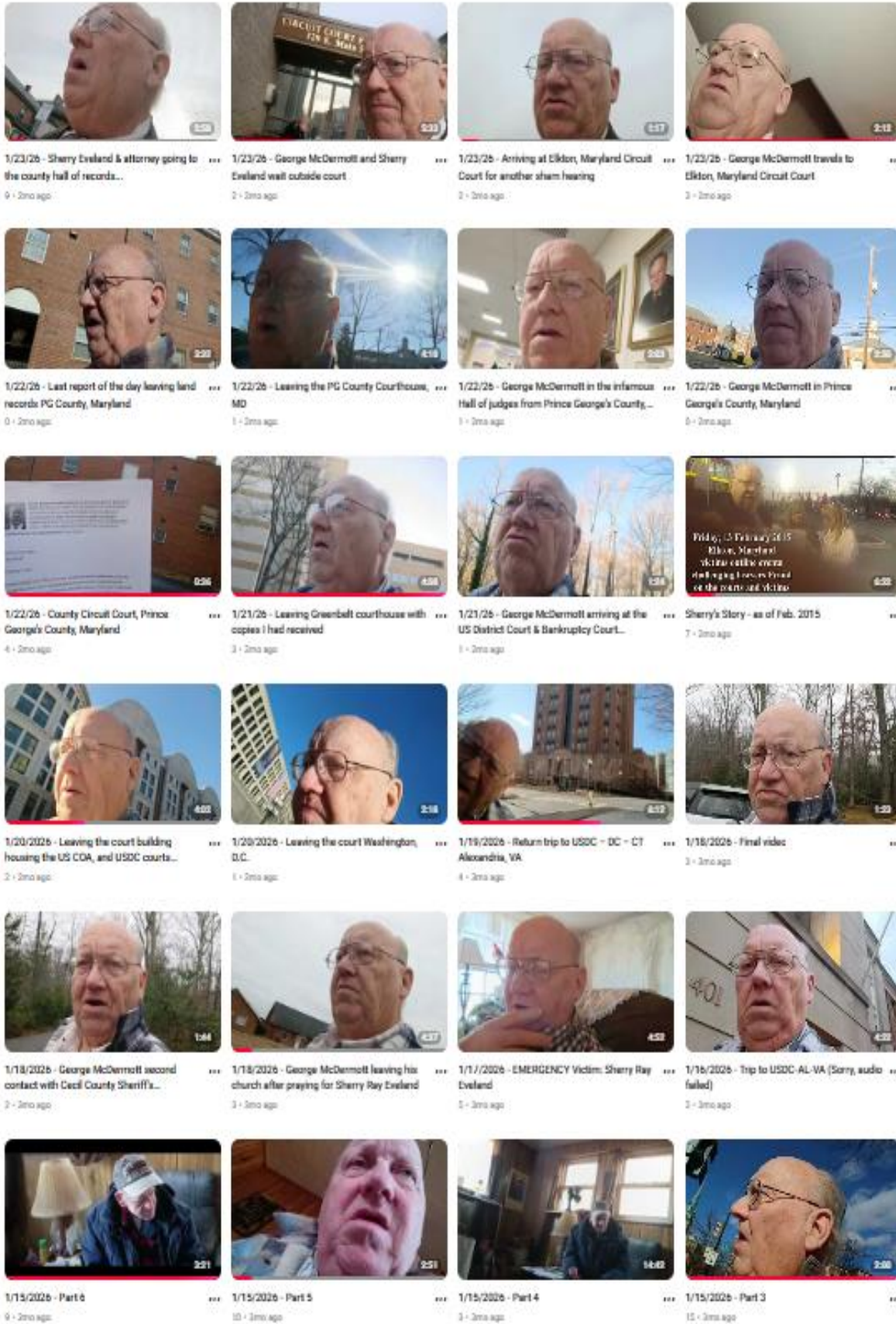

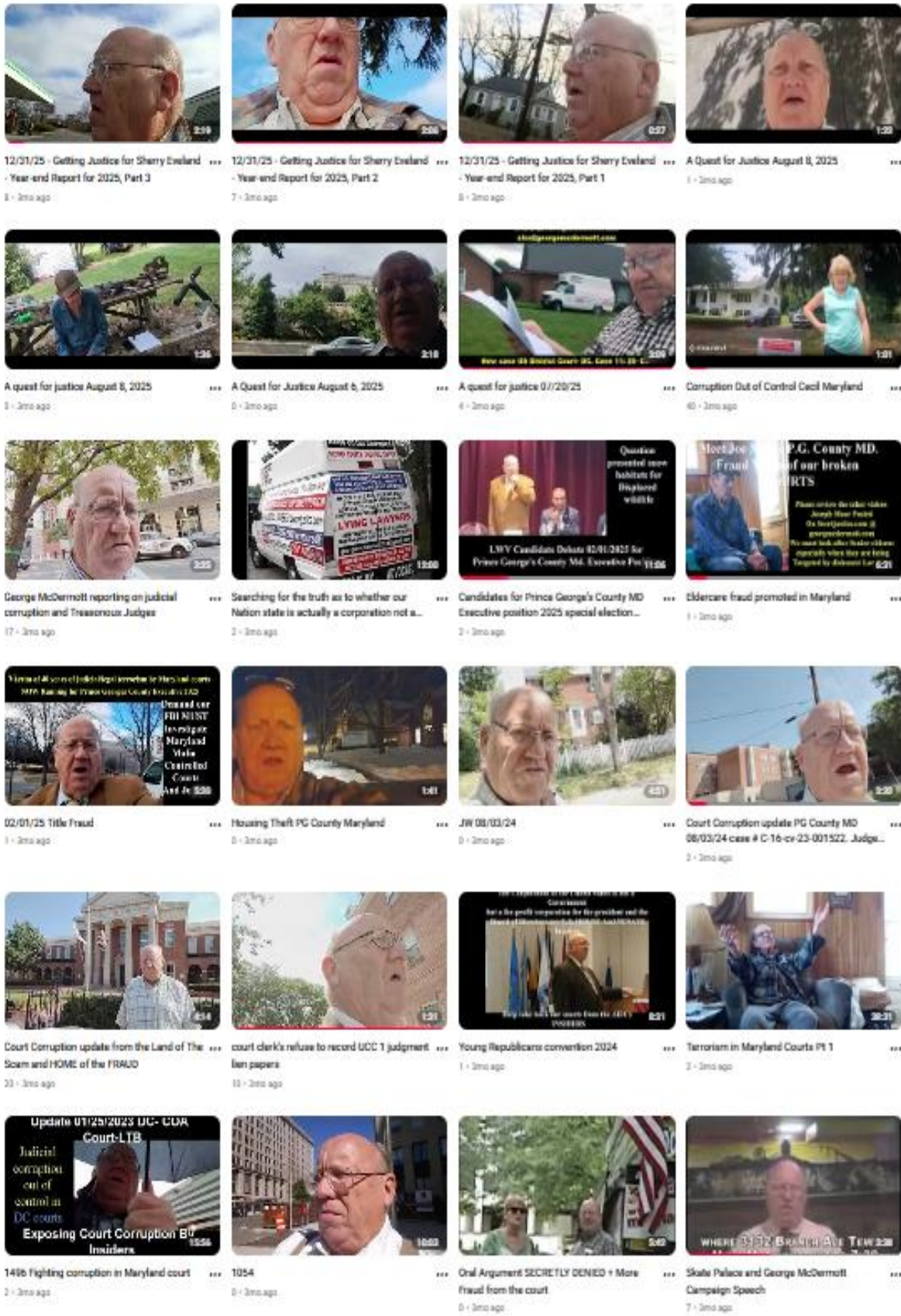
